Overview

Review issues related to software licensing as well as the licensing and delivery of other automated online services.

- Discuss software, platform, and infrastructure as a service.

Warranties, Disclaimers, Limitations, and Indemnities

- Cover issues and solutions associated with typical disclaimers and limitations used by licensors and services providers.
- Identify common types of indemnity and limited warranty provisions.

Governing Law and Jurisdiction Clauses

Discuss the importance of jurisdiction and forum clauses when parties to service and licensing agreements are in foreign jurisdictions.

- Cover topics of dispute resolution, arbitration, and mediation.
- Explore solutions to issues caused by highly variable jurisdiction clauses and dispute resolution provisions.

Service Level Agreements

Review typical provisions and issues in IT service agreements regarding outsourcing, software licensing, and online services agreements.

Escrow Agreements

Examine source code escrow and similar agreements to protect licensees in the event of default or insolvency of the licensor or service provider.

Data Security and Privacy Issues

Discuss issues with online services and cloud computing, including:

- Obligations of licensors, service providers, and customers
- Privacy laws, requirements for adequate information, and cyber security.

Cloud and IT Outsourcing Agreements

Cover RFPs, tendering issues, and typical negotiating points in technology contracting.
