Gladue Factors Through Multiple Lenses

Develop insight regarding the use of *Gladue* factors and evidence from the points of view of the Crown, the Defence, *Gladue* Report Writers, and the Bench.

Gladue Factor Evidence Post-Laboucane

Gain an in-depth understanding of how the Alberta Court of Appeal 2016 *Laboucane* decision provides guidance for Counsel and the Courts on how to effectively apply *Gladue* factors within the larger context of the sentencing approach within *Arcand*.

Consider the evolution of how *Gladue* factors impacts evidence, and examine the potential substantive and procedural issues raised by the *Laboucane* decision for both indigenous and non-indigenous offenders under s. 718.2(e).

Gladue Factors Post-Laboucane in Practice

Discover how to engage elders, community members, and *Gladue* report writers when preparing bail plans and sentencing. Observe a *Gladue* sentencing demonstration to illustrate the issues and evidentiary aspects arising from the *Laboucane* decision. Engage senior Crown and defence counsel, a *Gladue* Report writer, and a member of the Court in discussing best practices for bail and sentencing hearings.
